WARRANTY

HEXIS «BODYFENCE» warranty applies to the BODYFENCE* range of products (excluding accessories), which are used, transformed and implemented in accordance with the requirements stated in the HEXIS technical data sheets and application guides: <https://www.hexis-graphics.com/en/>
This warranty applies exclusively after completing the registration* and from the date of product installation on the vehicle. (Installation invoice as a proof)

This warranty exclusively covers against cracking and yellowing of the product (slight discoloration maybe noticed on vehicles after a period of time).
*The registration includes Filling in the booklet, completing the online form and applying the holographic sticker inside the car's door panel or attaching it on the receipt.

1. ELIGIBILITY CONDITIONS

HEXIS ME warrant the BODYFENCE* films (upon reference) for a duration of 5 years.

This warranty applies to professional shops and applicators with valid license.

To be valid, the warranty requires that the Applicator follows the below HEXIS MIDDLE EAST guidelines:

Manual Registration:

- Fill in the provided booklet and complete all the required details (shop name, date, batch number, chassis number, parts applied).
- Apply the holographic stickers inside the car (door panel) or attach it on the receipt.
- Take picture of the receipt showing the holographic sticker, chassis number and date. (If applicable)

The installation must be performed on the original paint and the purchaser must follow the maintenance requirements given for the BODYFENCE film.

This warranty is not transferable and the warranty coverage is only applicable to the original purchaser of the product.

2. LIMITATIONS

The BODYFENCE warranty applies to HEXIS ME products used by professionals and it does not apply to installations performed by private individuals.

Under no circumstances should the end user submit a claim or a compensation request to HEXIS ME within the framework of this warranty.

Regular maintenance is crucial, the film must imperatively be cleaned on weekly basis using pH- neutral soap and rinse with clear water.

In terms of climate effect, the degradation of materials is a natural and unavoidable phenomenon. A slight and progressive modification of the transparency and brightness, may be noticed after a period of time and it does not fall within the scope of this warranty.

A usage of our products that is not in accordance with the indications defined in our technical data sheets or application guides falls under the responsibility of the installer for any risk arising from this usage or application. In the case of usage that is not in accordance with the specifications in the technical data sheets, application guides and maintenance requirements, it is the responsibility of the installer to determine the compatibility between the HEXIS product and the application, and the risks and/or obligations related with this application.
